Age limit: Should be 28 years or below. Age relaxation is applicable as per Government of India rules.

No. of Vacancies: 20 (UR: 10; EWS: 01; OBC: 05; SC: 03 and ST: 01)

Nationality: The applicant must be an Indian Citizen.

Fellowship: CSIR/UGC/DBT/ICMR or any other direct fellowship holders in related disciplines are eligible.

Qualification Required: CSIR/UGC/DBT (CAT-I)/ICMR or any other direct fellowship holder (including other reserved categories) can apply. Junior Research Fellowship holder candidates having independent fellowship, with master degree or four year BS degree (55% and above or equivalent GPA in Chemistry/Biology or any branch of Life Sciences, Medical Physics/Physics with Post M.Sc Diploma in Radiological Physics or Medical Physics and Oncology related subject) are eligible to apply. Students in their final year of masters may also apply, provided they fulfill other qualifications.

Candidates meeting the age criteria and possessing the required qualification, experience, etc. and willing to work for the above-mentioned project may email their filled-in application in prescribed format (available in CNCI website advertisement (<https://www.cnci.ac.in/career>) to ugirhossainsk@cnci.ac.in , on or before the last date of receipt of applications as mentioned above. There is no need to send hard-copy of any application form / documents during initial application.
2. Late and incomplete applications or applications not submitted in the prescribed format will not be considered.
3. The above position will be filled purely on temporary CONTRACT appointment basis.
4. The rates of emoluments/stipend shown in this advertisement are as per the guidelines and as per the sanction.
5. Age relaxation is admissible in respect of SC/ST/OBC/PWD and women candidates as per government rules.
6. Engagement of applicant for a particular position will be decided by appointing authority.
7. Qualification & experience should be in relevant discipline/field and from an Institution of repute. Experience should have been gained after acquiring the minimum essential qualification.
